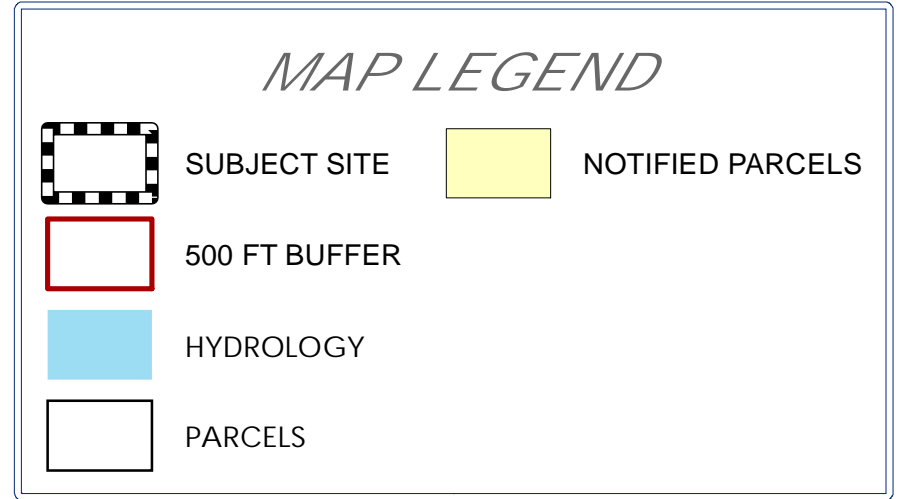

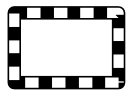
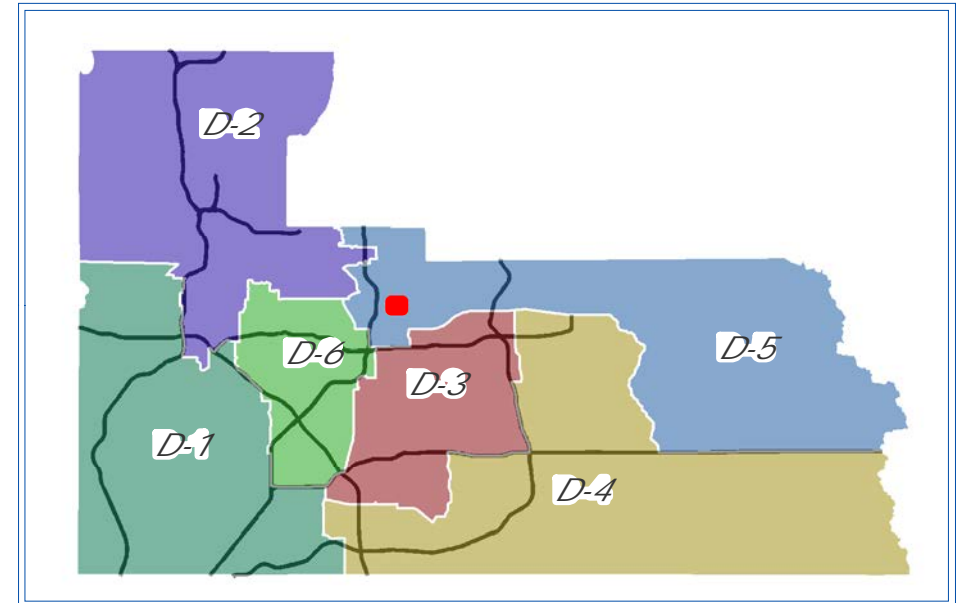

Public Notification Map

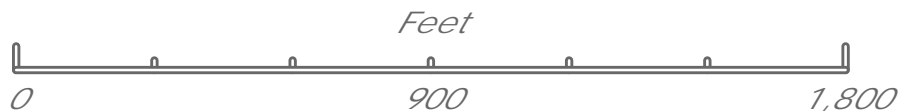
