SUBJECT: Approval of Contract Y24-2111, Provision of Community Services and Facility Use

ACTION REQUESTED:

Approval to award, contract Y24-2111, Provision of Community Services and Facility Use, with The Devereux Foundation, Inc., in the total contract award amount of \$420,140.42 for a one-year term.

PROCUREMENT:

The contract will provide counseling and case management services for youth and their families in six Neighborhood Center for Families (NCF). The performance period is December 1, 2023 through September 30, 2024.

FUNDING:

Funding is available in account number 0001-062-2540-8610.

APPROVALS:

The Citizens' Commission for Children Division concurs with this recommendation.

REMARKS:

In accordance with the Code of Ordinances, Part 1, Chapter 17, Article III, Section 17-289-Application and Exclusions, agreements between the Board and nonprofit organizations are excluded from competitive procurement requirements.

Under this contract, the Devereux Foundation will provide counseling services in six NCF locations and one case management position within one of the locations. This contract primarily provides services for intervention and prevention. NCFs include organizations such as schools, churches, non-profits and governmental agencies. These agencies and organizations are held

responsible for delivering contracted outcomes that are measurable. Each is involved as part of a single, collaborative entity. This enables separate agencies and organizations to act as a single unit in carrying out the mission to provide cohesive, integrated prevention services that immediately respond to community needs.
