In June 2017 and May 2020, the Govermental Accounting Standards Board issued statement no. 87 and no. 96, respectively, which now requires the recognition of all lease and subscription-based information technology software or services assets and liabilities over 12 months in length to now be recorded as liabilities and right-of-use assets. This budget amendment is for accounting purposes only and does not increase the actual amount disbursed for leases.

On November 30, 2021, the Board accepted from the U.S. Department of Homeland Security, through the Florida Department of Emergency Management, a sub-award for the State Homeland Security Grant Program – Issue 23 (MARC Radio Sustainment). The sub-award, in the amount of \$12,500, will fund mutual aid radio cache. The radio cache sustainment and maintenance of equipment is needed to continue participation as a local and regional responder, and in case of a declared emergency, a State of Florida Response Asset. The performance period for this grant is from January 27, 2022 through July 31, 2024.
