RECOMMENDATION:

Selection of Bacon Group, Inc. to provide Design Services for Orange County Animal Services Facility, Request for Proposals, Y22-804-RC. Request authority for the Procurement Division to negotiate and execute a contract with a not-to-exceed budget of \$3,000,000.

Proposals were evaluated by the Procurement Committee on February 11, 2022. Commissioner Nicole Wilson was assigned to the Procurement Committee.

PURPOSE:

This contract provides for design services for the Orange County Animal Services Facility to include design developments, proposed site plans, and cost estimation.

APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

REMARKS:

Four proposals were received in response to this Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in this RFP. The proposals for EXP U.S. Services, Inc., MLM-Martin Architects, Inc., and Rauhaus Freedenfield & Associates, L.L.P scored too low for Board consideration. One timely protest was received. In accordance with the Procurement Ordinance, a protest hearing was held on March 2, 2022. The protest committee unanimously voted to deny the protest. No appeals were received.
