**SUBJECT:** **Request for Public Hearing – February 10, 2026**  
To consider the adoption of an Ordinance amending Article II, Chapter 5 of the Orange County Code; modifying provisions pertaining to definitions, owner requirements and penalties for dogs classified as dangerous and not dangerous, compulsory sterilization upon first impoundment of animals, hold times for impounded animals, requirements for release of impounded animals, and establishing a new violation of said chapter; creating provisions related to minimum requirements and warranty requirements for sale of dog and cats, and the establishment of a trap-neuter-return program; and providing an effective date.
