ACTION REQUESTED:

Approval to award Invitation for Bids Y23-1037-AV, Water Meter Boxes for Orange County Utilities, to the low responsive and responsible bidder, Ferguson Enterprises dba Waterworks, in the estimated contract award amount of \$9,700,314.75 for a three-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

In the event the bidder recommended above fails to achieve timely compliance with pre-award deliverables, as defined in the Invitation for Bids, including, but not limited to, M/WBE participation sub-contract agreements, State Division of Corporations registration, E-verify, insurance and bonds, further request authorization for the Procurement Division to award to the next low responsive and responsible bidder as listed in the bid tabulation herein, to the extent practicable and advantageous to the County.

PROCUREMENT:

This contract will provide water meter boxes and components for the Utilities Department.

FUNDING:

Funding is available in account number 4420-038-1536-6350.

APPROVALS:

The Utilities Department and Business Development Division concur with this recommendation.

REMARKS:

Four bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Keaton Bros. Transportation was deemed non-responsive for failing to submit required documentation. Ferguson Enterprises dba Waterworks' price is reasonable, has a satisfactory record of performance, and is considered responsible. Therefore, recommendation for award is made to Ferguson Enterprises dba Waterworks.
