Emergency Management Services Division/Health Services Department

On September 23, 2021, the Board approved an estimated budget for the Emergency Medical Services (EMS) County Grant in the amount of \$200,685. The Florida Department of Health awarded the grant in the amount of \$209,823 and has also provided permission to carryforward \$1,090 in interest and \$186 in sales of surplus equipment from last fiscal year, which results in an increase of \$10,414 to the budget. The budget period for this grant is December 28, 2021 through December 28, 2022.

Proceeds from this year's grant will be used to provide enhancements to the countywide EMS System, purchase medical and training equipment, reality simulators, and other miscellaneous supplies and equipment. All awarded services were developed and approved by the EMS Advisory Council.

Therefore, in accordance with Section 129.06(2)(d), Florida Statutes, it is recommended that the following accounts be adjusted by the amounts shown.
