Management / Fiscal Agency Agreement for
Orange County Arts & Cultural Affairs
Tourist Development Tax (TDT) Revenue - Arts & Cultural Affairs Grants Program

THIS FIRST AMENDMENT, is made and entered into this 5th day of May 2026, by and between Orange County, a charter county and political subdivision of the State of Florida, whose address is 201 S. Rosalind Avenue, Fifth Floor, Orlando, Florida 32801, hereinafter referred to as the "County" and United Arts of Central Florida Inc., a nonprofit corporation under the laws of the State of Florida, 3025 Edgewater Dr. Orlando, Florida 32804, hereinafter referred to as the "AGENCY" together, the COUNTY and AGENCY shall be referred to as the "Parties".

RECITALS

WHEREAS, the COUNTY and AGENCY entered into a Management/Fiscal Agency Agreement for Orange County Arts & Cultural Affairs Tourist Development Tax (TDT) Revenue- Arts & Cultural Affairs Grants Program for a term beginning on October 1, 2025 and ending on September 30, 2026; and

WHEREAS, the Arts and Cultural Affairs Blockbuster and Special Events fund (Reserve Fund) is a reserve set aside for funding grants to successful Blockbuster & Special Events applicants. The grant program operates on a rolling basis and applications are periodic, therefore these funds roll over from year to year. The Arts & Cultural Affairs Advisory Council may, from time to time, recommend to the Board of County Commissioners that funds from this pool be used to increase grant pools for other grant programs as needed; and

WHEREAS, following the COUNTY's annual budget amendment, the COUNTY desires to allocate Two Million, One Hundred Eighty-Six Thousand, Four Hundred Fifty Dollars (\$2,186,450) to the Reserve Fund.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained, the Parties agree as follows:

1. **AMENDMENTS TO THE CONTRACT.** This Contract is hereby amended to revise the following section with additions being underlined.

A. Article II, Section 1d. shall be created as follows:

d) COUNTY will pay AGENCY Two Million, One Hundred Eighty-Six Thousand, Four Hundred Fifty Dollars (\$2,186,450) to be added to the Blockbuster and Special Events Reserve Fund.

2. **REMAINDER OF CONTRACT UNCHANGED.** Except as otherwise set forth herein, the remainder of the Contract shall remain unchanged and in full force and effect.
3. **EFFECTIVE DATE.** This First Amendment shall become effective upon the later of the date of execution by COUNTY or the date of execution by AGENCY.
4. **COUNTERPARTS.** This First Amendment may be executed in any number of counterparts, each of which shall be an original, but all of which shall constitute one and the same agreement.


