SUBJ: Approval of the Local Agency Program Supplemental Agreement with the

Florida Department of Transportation for the Orange County Traffic

Signal Cabinets Upgrade Project

Submitted for approval and execution is a Local Agency Program Supplemental Agreement between Orange County and the State of Florida Department of Transportation (FDOT) for the Orange County Traffic Signal Cabinets Upgrade Project. The project, funded by the Federal Highway Administration, is to design the upgrade of traffic signal cabinets at 164 intersections to the latest standards. It will also include installation of uninterruptible power supply cabinets and communication switches at additional intersections.

Upgrading traffic signal cabinets will replace existing cabinets, which have expired service life, with new cabinets that can house additional equipment and comply with the latest FDOT standards. It will also improve maintenance efficiency and prepare the County for adding new devices to allow data collection, tracking performance measures, and interface with connected and autonomous vehicles.

The purpose of the Supplemental Agreement is to reduce federal and local funding to an amount equal to the negotiated design contract amount. The total estimated cost for design of this project was \$700,258, however, the negotiated design contract amount is \$686,098. The federal funding is now 100% with no cost to the County.

The County Attorney's Office and the Public Works Traffic Engineering Division have reviewed the Local Agency Program Agreement and find it acceptable.

Action Requested: Approval and execution of State of Florida Department of

Transportation Local Agency Program Supplemental Agreement for the Orange County Traffic Signal Cabinets Upgrade Project. There is no cost to the County. All Districts.

The above list is subject to change based on survey and feasibility. The project shall also include utility coordination, environmental analysis, maintenance of traffic design, right-of-way evaluation, survey, and permitting.

Reason for Supplement and supporting engineering and/or cost analysis:

- 1. Pursuant to Paragraph 4.0 Project Cost of the Local Agency Program Agreement, the Recipient and the Department acknowledge and agree that the Schedule of Financial Assistance for Design that includes the authorized and encumbered Federal funding and Local funding on the project shall be reduced to an amount equal to the Recipient's consultant contract award amount of \$686,098.00. This results in a reduction of total design funding by \$14,160.00. Federal funding is to be reduced by \$13,902.00, which is the difference between previous federal funding of \$700,000.00 and the current federal funding of \$686,098.00. Local funding is to be reduced by \$258.00, which is the difference between previous local funding of \$258.00 and the current local funding of \$0.00.
- 2. Revisions to the federal and local funding amounts attributed to the amounts referenced above are reflected in the Adjusted Exhibit "B" Schedule of Financial Assistance, and in Exhibit "E", Federal Financial Assistance (Single Audit Act), attached hereto and incorporated herein.
- 3. The Recipient Resolution authorizing entry into this Supplemental Agreement is attached and incorporated into this Supplemental Agreement as Exhibit "D".


