ACTION REQUESTED:

Approval of Contract Y24-2040, Provision of Community Services and Facility Use, with Community Coordinated Care for Children, Inc., in the total contract award amount of \$2,100,000 for a three-year term.

PURPOSE:

This contract will provide funds for early head start programming to provide safe and developmentally enriching care which promotes the physical, cognitive, social, and emotional development of infants and toddlers. The performance period is January 1, 2024 through December 31, 2026.

FUNDING:

Funding is available in account number 0001-062-2556-8610.

APPROVALS:

The Citizens' Commission for Children Division concurs with the funding recommendation. Community Coordinated Care for Children, Inc. has previously received funding from the Citizens' Commission for Children Division.

REMARKS:
