The contract will provide medications to the Fire Rescue Department for the delivery of emergency medical services.

REMARKS

Four bids were received and evaluated for responsiveness, responsibility, and price. Award is recommended to the lowest responsive and responsible bidders, Bound Tree Medical LLC, Florida Discount Drugs dba Taylor's Pharmacy, Henry Schein, Inc., and Medline Industries, Inc. These four bidders meet all of the requirements of this solicitation.

Multiple awards are necessary to meet the projected demands. Award is made on an item by item basis to maximize cost savings. Secondary and tertiary sources of supply are recommended to ensure continuity during manufacturing shortages.

Therefore, recommendation for award is made to Bound Tree Medical LLC, Florida Discount Drugs dba Taylor's Pharmacy, Henry Schein, Inc., and Medline Industries, Inc.
