RECOMMENDATION:

Selection of one firm and an alternate to provide COBRA, Retiree, Direct Bill and FSA Administrative Services, Request for Proposals Y20-1053-AH, from the following firms listed alphabetically:

Chard Snyder & Associates, LLC Total Administrative Services Corporation

Request authorization for the Procurement Division to negotiate and execute a contract for a three-year term provided it does not exceed the budget of \$270,000. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

The proposals were evaluated by the Procurement Committee on November 4, 2020. Commissioner Maribel Gomez Cordero was assigned to the Procurement Committee.

PURPOSE:

This contract provides benefit administrative services including flexible spending account administration, (COBRA) administration and compliance, retiree billing and administration, post tax billing administration for overage dependents (26-30 years old), and Affordable Care Act full-time equivalent employees eligible for medical coverage.

FUNDING:

Funding is available in account numbers 0001-025-0277-3197 and 5540-025-0279-3197.

DISCUSSION

Ten proposals were received in response to this Request for Proposals (RFP). The proposals received from Clarity Benefit Solutions, Discovery Benefits, LLC, HSA Bank, and Surety Life & Health Insurance Company were deemed non-responsive for failing to
