RECOMMENDATION:

Selection of Adventist Health System/Sunbelt, Inc. dba AdventHealth Centra Care, to provide Occupational Medical Services, Request for Proposals Y23-134-KK.

Request authorization for the Procurement Division to negotiate and execute a contract in the estimated amount of \$3,033,210 for a three-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

The proposal was evaluated by the Procurement Committee on May 17, 2023. Commissioner Mirabel Gomez Cordero was assigned to the Procurement Committee.

PURPOSE:

The resulting contract for occupational medical services will provide post-employment physicals and annual physicals for employees.

APPROVALS:

The Risk Management Division and Business Development Division concur with this recommendation.

REMARKS:

One proposal was received in response to this Request for Proposals (RFP). The Procurement Committee evaluated the proposal in accordance with the criteria established in this RFP. Adventist Health System/Sunbelt, Inc. dba AdventHealth Centra Care meets all specifications and other requirements of the RFP. Pricing was determined to be reasonable, as the proposed pricing reflects a 3% increase from the current contract.

To ensure an open and competitive solicitation process, the RFP was posted on the County's e-procurement platform. A query from staff to potential proposers that declined to participate in this procurement resulted in the following:

- Heart of Gold Superior Lab Services: Did not believe they had the resources to perform the scope of services.
- Aya Healthcare, Inc.: Did not submit due to their current workload.
- Quantgene, Inc.: Did not believe the services they offered fit the entirety of the scope of the RFP.
- M&S Global Services, LLC: Their model focuses on mobile, rapid-onsite testing and they did not believe their infrastructure fit the scope of the RFP.
- SPM: Did not agree with the requirements of the RFP.

The Procurement Committee's consensus scores are attached.
