Application for Federal Assistance related to Cost-of-Living Adjustment (2.6 %) FY 2018

The Head Start Division requests Board approval of the Application for Federal Assistance related to Cost-of-Living Adjustment (COLA) between the Department of Health and Human Services, Administration for Children and Families, Office of Head Start and Orange County. The total COLA funds in the estimated amount of \$365,156, includes \$331,177 that will be used to offset higher operational costs of salaries, FICA, and retirement costs and \$33,979 which will be used for Training and Technical Assistance The non-federal match of \$91,289 is derived from donations of goods and services and in-kind contributions from the County.

The Application for Federal Assistance includes a Compendium of required Certifications and Assurances for non-construction programs, Certifications regarding Lobbying for Contracts, Grants, Loans and Cooperative Agreements; Certification regarding compliance with Compensation Cap (Level II of the Executive Schedule); Certification of Filing and Payment of Federal Taxes; and Employee Compensation Cap Compliance Assurance. The term of the grant is from October 1, 2017 through September 30, 2018. The Head Start Policy Council approved the COLA grant at their meeting on May 17, 2018.

ORANGE COUNTY HEAD START PROGRAM APPLICATION FOR FEDERAL ASSISTANCE RELATED TO COST -OF-LIVING ADJUSTMENT (2.6%) FY 2018

Budget Narrative

October 1, 2017 through September 30, 2018

The Orange County Head Start Program is requesting \$331,177 in federal funding to provide Head Start Services to 1,536 children throughout Orange County, FL. The Orange County Head Start Program will use the permanent 2.6% COLA to pay for higher operating costs and to permanently increase staff salaries and fringe Benefits.

Orange County Head Start Program is also requesting \$33,979 in Training and Technical Assistance dollars to increase training and professional development for staff.

Orange County Cost of Living Increase

The Orange County Board of County Commissioners had approved a 3.5% cost of living salary increase for all Orange County Government employees. All Orange County Head Start staff received this salary increase as well as an increase in base salaries within the established pay grades.

The COLA award of \$331,177 in federal funds will assist with salaries in the following amounts:

Amount Allocated	Description
\$285,867	Salaries for staff in the Orange County Head Start Program
\$21,869	FICA for staff in the Orange County Head Start Program
\$23,441	Retirement cost at 7.91% for Orange County Head Start Staff

The total of all budget categories equals Orange County Head Start's requested amount of \$331,177 in federal funding and equals the amount of the permanent COLA of 2.6%. The Orange County Head Start Division, along with The Orange County Head Start Policy Council has determined that this will be the best allocation of the permanent COLA dollars. Because of the increased salary and fringe costs, the requested award will help Orange County Head Start to permanently improve alignment of the pay scale of its employees in salaries and benefits with other providers of like services.

The Orange County Head Start program will provide the requested \$82,794, nonfederal share through donations of goods and services, in-kind service and services from the Board of County Commissioners.

Technical Training and Assistance

Technical training and assistance funds in the amount of \$33,979 will be used to provide educational and technical training for our bi-annual pre-service employee training. In addition, this funding will support professional development opportunities, area related conferences and educational assistance. The Orange County Head Start Program will provide the requested \$8,495, non-federal share through donations of goods and services, in-kind service and services from the Board of County Commissioners.

The Consolidated Appropriations Act, 2018, contains an increase of approximately \$610 million for programs under the Head Start Act for Fiscal Year (FY) 2018. A portion of the increase provides a cost-of-living adjustment (COLA) of 2.6 percent, depending on final funding decisions, to assist grantees in increasing staff salaries and fringe benefits and offsetting higher operating costs.

Grants with significantly low percentages of training and technical assistance (T/TA) dollars may see an increase in those funds over previous years.
