# Subject:

Ordinance No. 2021-29 Relating to a street name change; renaming the westerly portion of "East Concord Street," a portion of which is described in the plat thereof, as recorded in Plat Book O, page 19, of the Public Records of Orange County, Florida, generally located between Herndon Avenue, west of Rickenbacker Drive to "Showalter Aviation Street" (SNC2020-10002) (Economic Development)

# **Summary:**

The attached ordinance will rename the westerly portion of East Concord Street, generally located between Herndon Ave. and Rickenbacker Dr. ( $\pm 1640$  linear ft.  $\pm 1.7$  acres). The Street Name Change request affects a limited street segment partially adjacent to GOAA property to the south.

The Municipal Planning Board (MPB) recommended approval of this request (case SNC2020-10002) on February 16, 2021.

City Council accepted the MPB minutes concerning this request on March 15, 2021. The City Council recommended approval of the 1st reading of the subject ordinance on April 12, 2021.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, RELATING TO A STREET NAME CHANGE; RENAMING THE WESTERLY PORTION OF "EAST CONCORD STREET," A PORTION OF WHICH IS DESCRIBED IN THE PLAT ORLANDO VILLA, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK O, PAGE 19, OF THE PUBLIC RECORDS ORANGE COUNTY, FLORIDA, **GENERALLY** LOCATED BETWEEN HERNDON AVENUE, WEST OF RICKENBACKER DRIVE TO "SHOWALTER AVIATION STREET"; DIRECTING **AMENDMENTS** TO OFFICIAL MAPS OF THE CITY OF ORLANDO, FLORIDA; PROVIDING FOR SEVERABILITY, CORRECTION OF SCRIVENER'S ERRORS, AND AN EFFECTIVE DATE.

WHEREAS, there exists a certain segment of public right-of-way within the jurisdictional boundaries of the City of Orlando, Florida, currently known and marked, and designated on the official maps of the City of Orlando, Florida, as "East Concord Street," and

WHEREAS, the City Council of the City of Orlando (the "Orlando City Council") would like to honor the founders of Showalter Aviation for providing more than 60 years of fixed based operations at the Orlando Executive Airport; and

WHEREAS, the Orlando City Council hereby finds that it is fitting to rename a portion of East Concord Street, to Showalter Aviation Street; and

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ORLANDO, FLORIDA, AS FOLLOWS:

**SECTION 1. STREET NAME CHANGE.** After due notice and public hearing, and having met all other conditions precedent in accordance with sections 65.537 and 65.538, Code of the City of Orlando, Florida, and all other applicable law, the name of the public street segment described and depicted in Exhibit "A" to this ordinance is hereby changed from "East Concord Street" to "Showalter Aviation Street."


