Approval of Fiscal Year 2023 Assistance to Firefighters Grant Award Number: EMW-2023-FG-04803 in the amount of \$2,685,454.54 with \$268,545.46 matching non-federal funds for a total amount of \$2,954,000. (Planning and Technical Services Division)

**PROJECT:** Fiscal Year 2023 Assistance to Firefighters Grant, Award Number: EMW-2023-FG-04803

**PURPOSE:** The Department of Homeland Security, through the Federal Emergency Management Agency, awarded Fiscal Year 2023 Assistance to Firefighters Grant, Award number: EMW-2023-FG-04803 to the Orange County Fire Rescue Department in the amount of \$2,685,454.54 with \$268,545.46 matching non-federal funds for a total amount of \$2,954,000. This grant project focuses on firefighter wellness by reducing the exposure to harmful pollutants from engine exhaust and in funding a pilot annual behavioral health evaluation. The vehicle mounted exhaust filter project has a budget of \$2,310,000 with a goal of outfitting every vehicle in the fire department fleet, for a total of 231 apparatus. The behavioral health evaluation pilot program has a budget of \$644,000 and will provide a behavioral health evaluation to all operations personnel, for a total of 1610 personnel. This grant has a performance period of September 26, 2024 through September 25, 2026 and requires a 10% match.

Recipients of federal awards under programs that prohibit supplanting by law must ensure that federal funds supplement but do not supplant non-federal funds that, in the absence of such federal funds, would otherwise have been made available for the same purpose.

**Article 30 Procurement of Recovered Materials**

States, political subdivisions of states, and their contractors must comply with Section 6002 of the Solid Waste Disposal Act, Pub. L. No. 89-272 (1965) (codified as amended by the Resource Conservation and Recovery Act at 42 U.S.C. § 6962) and 2 C.F.R. § 200.323. The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 C.F.R. Part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition.

**Article 31 Rehabilitation Act of 1973**

The Buy America preference only applies to articles, materials, and supplies that are consumed in, incorporated into, or affixed to an infrastructure project. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project. Waivers When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. The agency should notify the recipient for information on the process for requesting a waiver from these requirements. (a) When the Federal agency has determined that one of the following exceptions applies, the awarding official may waive the application of the domestic content procurement preference in any case in which the agency determines that: (1) applying the domestic content procurement preference would be inconsistent with the public interest; (2) the types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or (3) the inclusion of iron, steel, manufactured products, or construction materials produced in the United States will increase the cost of the overall project by more than 25 percent. A request to waive the application of the domestic content procurement preference must be in writing. The agency will provide instructions on the format, contents, and supporting materials required for any waiver request. Waiver requests are subject to public comment periods of no less than 15 days and must be reviewed by the Made in America Office. There may be instances where an award qualifies, in whole or in part, for an existing waiver described at “Buy America” Preference in FEMA Financial Assistance Programs for Infrastructure | FEMA.gov. Definitions The definitions applicable to this term are set forth at 2 C.F.R. § 184.3, the full text of which is incorporated by reference.
