REMARKS:

Kerina Village, LLC (Kerina), the School Board of Orange County, Florida (OCPS), and County are presently in negotiations related to a possible new park site proposed to be located partially upon certain lands to be donated to County by Kerina and partially upon abutting lands owned by OCPS, all lying east of South Apopka Vineland Road and just north of the recently vacated Fenton Road corridor. Such negotiations are expected to result in a Donation Agreement between County and Kerina and a School Facility Joint Use Agreement between County and OCPS being brought to the Board for approval later this year.

However, in order to advance the project, OCPS has agreed that County may have access to the OCPS lands to commence County's due diligence activities while negotiations of the School Facility Joint Use Agreement are ongoing. This Right of Entry provides the terms and conditions upon which County may enter upon the OCPS lands and conduct its due diligence activities.

This Right of Entry will not be recorded.

RIGHT OF ENTRY

For and in consideration of \$1.00, other valuable considerations and benefits, THE SCHOOL BOARD OF ORANGE COUNTY, FLORIDA, a public corporate body organized and existing under the laws of the State of Florida ("School Board"), does hereby give, grant and bargain subject to terms provided herein, to ORANGE COUNTY, FLORIDA, a charter county and a political subdivision of the State of Florida, (the "County"), this certain right of entry to enter upon the portion of lands described as follows:

for the purpose of conducting due diligence investigations on the Property by the County and/or its assigns.

To the extent provided by Section 768.28, Florida Statutes, and without otherwise waiving sovereign immunity, the County hereby indemnifies the School Board for liability for any property damage or for death or personal injury occurring on the above referenced property or any surrounding property in connection with due diligence investigations provided by the County or its employees, agents, independent contractors, guests, invitee or licensees use of the property.

The County has represented and hereby agrees to complete all of the work on prior to December 31, 2019. This Right of Entry shall expire on December 31, 2019.

By use of this Right of Entry, the County accepts the obligations herein.
