- 1) A waiver from Section 38-1287(4) to allow paving setbacks reduced to zero (0) feet, in lieu of 7.5 feet between internal parcels.
- A waiver from Section 38-1287(2) to allow building setbacks reduced to zero (0) feet, in lieu of a 30-foot building setback between internal parcels.


