Meal Service Agreements between Orange County, Florida
and School Board of Orange County, Florida
regarding School Food Service

The Head Start Division requests Board approval of 11 Meal Service Agreements between the School Board and Orange County, Florida. These agreements will allow the School Food Service to provide Head Start children with two-thirds of the daily nutritional requirements. Meals will be furnished by the School Board Food Service at the following 11 Head Start sites: Aloma, Dillard, Dover Shores, Engelwood, Evans, Hungerford Elementary, McCoy, Three Points, Ventura, Washington Shores Early Learning and Washington Shores Elementary. The number of meals and snacks are subject to change due to COVID-19 and the opening of Orange County Public School sites.

The Florida Childcare Food Program funds in the estimated amount of \$315,002.20 will be used to cover the cost of meals. The term of these agreements is from October 1, 2020 through September 30, 2021. The County Attorney's Office and Risk Management Division have reviewed this agreement for legality and compliance with County policy guidelines.

ACTION REQUESTED: Approval and execution of Agreements between Orange County, Florida and The School Board of Orange County, Florida related to meal services at Aloma, Dillard, Dover Shores, Engelwood, Evans, Hungerford Elementary, McCoy, Three Points, Ventura, Washington Shores Early Learning, and Washington Shores Elementary Head Start sites.
