# **ACTION REQUESTED:**

Approval to award Invitation for Bids Y24-750-GO, Housing and Community Development Facility Heating Ventilation Air Conditioning System Replacement, to the low responsive and responsible bidder, Air Mechanical & Service Corp., in the total contract award amount of \$587,000.

## PROCUREMENT:

Work under this contract consists of replacing the Heating Ventilation Air Conditioning System for the Housing and Community Development Facility. This project is located in District 3.

#### **FUNDING:**

Funding is available in account number 1023-043-2049-3810.

### APPROVALS:

The Capital Projects Division and Business Development Division concur with this recommendation.

#### **REMARKS:**

Two bids were received in response to this Invitation for Bids and evaluated for responsiveness, responsibility, and price reasonableness. The bid submitted by Poli Construction, Inc. was deemed non-responsive by the Procurement Division, based on the analysis provided by the Business Development Division, which identified that the M/WBE participation goal was not achieved, and sufficient good faith effort was not provided.

The bid submitted from Air Mechanical & Service Corp. is considered reasonable based on comparison to the engineer's estimate. References provided were satisfactory for this type of work and Air Mechanical & Service Corp. has been determined to be responsible. The Business Development Division evaluated two bids submitted for this project. The Business Development Division completed an M/WBE Availability Analysis. The scope of services for this project had M/WBE availability. As a result, the M/WBE goal remained at 25%. At the time of bid opening, at least 100 firms were certified to provide the scope of services at the subcontract level.

The apparent low bid, submitted by Air Mechanical & Service Corp., reported 24.24% in M/WBE participation. The apparent low bid did not meet the Orange County M/WBE participation goal per the Ordinance requirement. The bidder indicated that they have historically performed (40% In-house) the scope of services denoted on the Good Faith Effort exception form. Per the Ordinance, Sec. 17-321, A prime contractor is not required to subcontract out work that it has historically and consistently performed with its own work force. Good Faith Effort documentation was achieved on the remaining 60% of the scopes of services. Please note the following certified M/WBE participation:

The second low bid, submitted by Poli Construction, Inc., reported 7.50% in M/WBE participation. The second low bid did not meet the Orange County M/WBE participation goal per the Ordinance requirement.
