Approval of Commercial Refuse License for All County Recycling & Shredding of Orlando, LLC dba Orlando Recycling to provide solid waste hauling services to commercial generators in Orange County for a five-year term. All Districts. (Solid Waste Division)

PURPOSE: The Solid Waste Division has received a commercial refuse license application from All County Recycling & Shredding of Orlando, LLC dba Orlando Recycling, to provide solid waste hauling services to multi-family, construction and demolition, and other commercial generators in Orange County.
