



SUBJECT: **April 5, 2022 – Consent Agenda Item**
Approval of Extension of Contract Y19-163 Management/Fiscal Agency Agreement

On May 22, 2018, the Arts and Cultural Affairs Advisory Council presented its recommendations to the Board for the allocation of the Tourist Development Tax (TDT) to the various arts programs. Funding for these preliminary recommendations was included in the adopted FY2019 budget that was approved on September 20, 2018.

United Arts of Central Florida, Inc. serves as the fiscal agent to manage compliance and distribution of the funding, as directed by Orange County. This agreement provides funding for the promotion of various arts organizations that will attract cultural tourists to Orange County and to strengthen the community's cultural infrastructure.

On October 16, 2018, the Board approved execution of Contract Y19-163 in the amount of \$6,152,677 for the performance period of October 1, 2018 through May 31, 2021. As a result of the Global Pandemic Covid-19, projects associated with this agreement have been delayed. As such, an extension through May 31, 2023 is requested to provide adequate time for postponed art installations to be completed. No additional funding is required or associated with this request.
