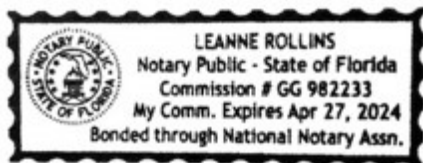

You are invited to attend and be heard regarding a request by:

Applicant: Bubba E. Shaffer Family Trust, Bubba E. Shaffer Trustee
Consideration: Request for an after-the-fact Private Boat Ramp Permit (BR-17-07-001) to authorize an existing, unpermitted private boat ramp on the shoreline of Lake Whippoorwill. The applicant is also requesting a variance to Chapter 15, Article XV, Section 15-605(b)(11) (side setback) to allow the existing ramp to remain with a 5.5 foot setback from the southern projected property line: pursuant to Orange County Code, Chapter 15, Article XV, Section 15-605(d)(2).
Location: District 4; Lake Whippoorwill, located at 12488 Kirby Smith Road, Orlando, FL 32832; Orange County, Florida (legal property description on file in Environmental Protection Division).
