The Membership and Mission Review Board (MMRB) is composed of nine members, one appointed from each of the county commission districts upon recommendation of the district commissioner, one appointed upon recommendation of the County Mayor, and two at large members nominated by the County Mayor or any County Commissioner and appointed by the full Board. The Board must confirm all appointments.

The terms of two of the members of the MMRB, Ronald Rogers and Roxy Santiago, expired December 31, 2019. Both Mr. Rogers and Ms. Santiago serve in the at large representative category. Both Mr. Rogers and Ms. Santiago wish to continue serving on the MMRB. The MMRB does not have term expirations, so both members are eligible for reappointment. The term is for two years.
