Dear Mayor Demings:

The Department of Economic Opportunity ("Department") has completed its review of the comprehensive plan amendment adopted by Orange County (Amendment No. 21-01ESR, proposed with 18-05ESR) by Ordinance No. 2020-39 on December 15, 2020. We have reviewed the amendment in accordance with the expedited state review process set forth in Section 163.3184(2) and (3), Florida Statutes, and identified no provision that necessitates a challenge of the Ordinance adopting the amendment.

If the plan amendment is not challenged by an affected person, the amendment will become effective 31 days after the Department notified the local government that the plan amendment package was complete. If the plan amendment is challenged by an affected person, the amendment will not become effective until the Department or the Administration Commission enters a final order determining the amendment to be "In Compliance."

The Orange County Board of County Commissioners (BCC) is pleased to transmit to the Florida Department of Economic Opportunity this 2018-2 (Continued Session IV) adoption packet, which consists of Regular Cycle State-Expedited Review Amendments (2018-2-A-1-2 and 2018-2-FLUE-3) to the 2010-2030 Comprehensive Plan. These amendments were adopted separately from other amendments in the 2018-2 Regular Cycle and, therefore, are referred to as 2018-2 (Continued Session IV) for Orange County filing purposes. Transmittal public hearings for these amendments were held June 21, 2018, and July 10, 2018, before the Local Planning Agency (LPA) and Board of County Commissioners (BCC), respectively. The proposed amendments' prior LPA adoption public hearings were held October 18, 2018, and both amendments were recommended for adoption. The amendments were remanded by the Board of County Commissioners (BCC) on July 7, 2020, to return to the LPA for further review, as the applicant's requested changes to the original application were considered substantial. The new adoption public hearings for these amendments were held November 19, 2020, and December 15, 2020, before the LPA and BCC, respectively. One paper and two electronic copies (CD) of the adopted amendment are enclosed.

Expedited State Review Process Regular Cycle Amendment

Per 163.3184(3), Florida Statutes, please note the following:

The Regular Cycle amendments subject to the State-Expedited Review process entails one privatelyinitiated Future Land Use Map Amendment and one staff-initiated text amendment. The Regular Cycle Amendments were included on a regular agenda.
