Re: Request Number M22-022 to amend a MSTU for **Big Sand Lake**

Type of Hearing: To amend the Municipal Service Taxing Unit (MSTU) for general lake cleaning maintenance, aquatic plant control and navigational improvements using a millage assessment. The amendment would include **Bayfront on Sand Lake** and provide revised legal description of properties for the metes and bounds parcels, condominiums, and subdivisions within the boundaries of the Big Sand Lake MSTU.

Hearing Required by F. S.# Florida Statute Sections 125.01 (01) (q) and 200.066 and 200.071. This public hearing may be scheduled any time prior to December 31, 2022.

Advertising Requirements /
Timeframe: **Publish only one (1) time and must be published at least twenty (20) days prior to the public hearing with the advertisement date as Sunday, November 20, 2022.**

Notify Abutters: Special Assessments will mail public hearing notices to all of the affected property owners.

Estimated Time Required: One (1) minute

Report: At the request of Momtaz Barq with Terra-Max Engineering, staff recommends the Big Sand Lake MSTU be amended to include parcels / lots in **Bayfront on Sand Lake** to provide revised Exhibits for the metes and bounds parcels, condominiums, and subdivisions for the boundaries of the Big Sand Lake MSTU. The amendment provides a revised legal description of properties within the existing boundaries for the MSTU would be effective immediately.

The revised legal description of properties within the existing boundary should not impact the current tax millage rate of 0.1378 mills or \$0.14 per every one thousand dollars of all taxable assessed real property.

WHEREAS, Chapter 125.01 (01) (q), Florida Statutes, grants Orange County the power to establish a Municipal Service Taxing Unit ("MSTU") for any part of the unincorporated areas of Orange County; and

WHEREAS, the Board of County Commissioners of Orange County ("Board") is the governing board ("County"); and

WHEREAS, the Board established an MSTU by resolution adopted December 19, 1995 recorded in Book 5004, Pages 4578 through 4584, in the Public Records of Orange County; as amended on December 5, 2006 and recorded in Book 9022, Pages 3278 through 3287; as amended on October 4, 2011 and recorded in Book 10278, Pages 4146 through 4147, to allow authorized use of funds for navigational improvements; as amended on December 16, 2014 and recorded in Book 10855, Page 1747; as amended on December 17, 2019 and recorded in Document Number 20200016579, Pages 1 through 14; and further amended on October 26, 2021 and recorded in Document Number 20210692551, Pages 1 through 14 (such resolutions are collectively referred to herein as the "MSTU Resolution" and such MSTU is referred to herein as the "Big Sand Lake MSTU"); and

WHEREAS, the purpose of the Big Sand Lake MSTU is to provide for general lake cleaning, maintenance, aquatic plant control and navigational improvements, together with certain other costs pertaining to the operation of such MSTU; and

WHEREAS, the Board wishes to amend and expand the aforesaid MSTU Resolutions to provide a revised legal description of properties in said MSTU, which properties are set forth on Exhibit "A", which describes certain properties by metes and bounds, Exhibit "B" describing Condominium properties, and Exhibit "C" for subdivisions,

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY, FLORIDA;

1. The foregoing "WHEREAS" clauses are declared to be true and correct and are hereby incorporated into the text of the Resolution.

2. The legal description of the properties affected by the Big Sand Lake MSTU Resolution is hereby amended to provide that the boundaries of said MSTU should be as set forth on Exhibit "A" for metes and bounds parcels, Exhibit "B" for Condominiums, and Exhibit "C" for certain subdivisions. Exhibit "D" and Exhibit "E" provide maps of the area that surrounds Big Sand Lake condominiums and subdivision additions.

3. Except as herein specifically provided all the remaining terms and conditions of the Resolutions, dated December 19, 1995, December 5, 2006, October 4, 2011, December 16, 2014, December 17, 2019, and October 26, 2021, shall remain in full force and effect.

4. This amendment shall take effect upon adoption by the Board of County Commissioners, and the provisions of the Big Sand Lake MSTU Resolutions dated December 19, 1995, December 5, 2006, October 4, 2011, December 16, 2014, December 17, 2019, and October 26, 2021 shall apply to all properties described on Exhibits A, B and C of this Amended Resolution.

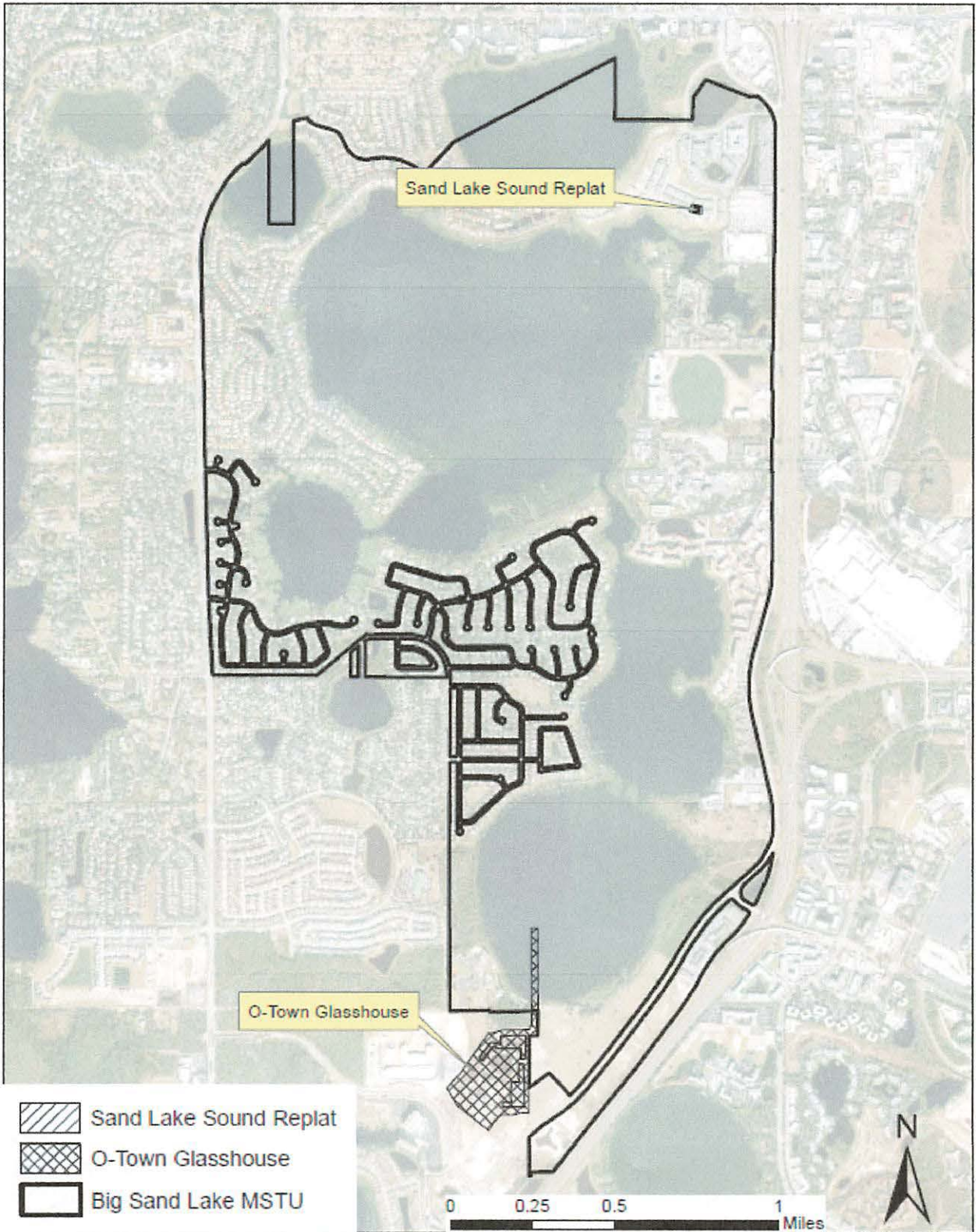

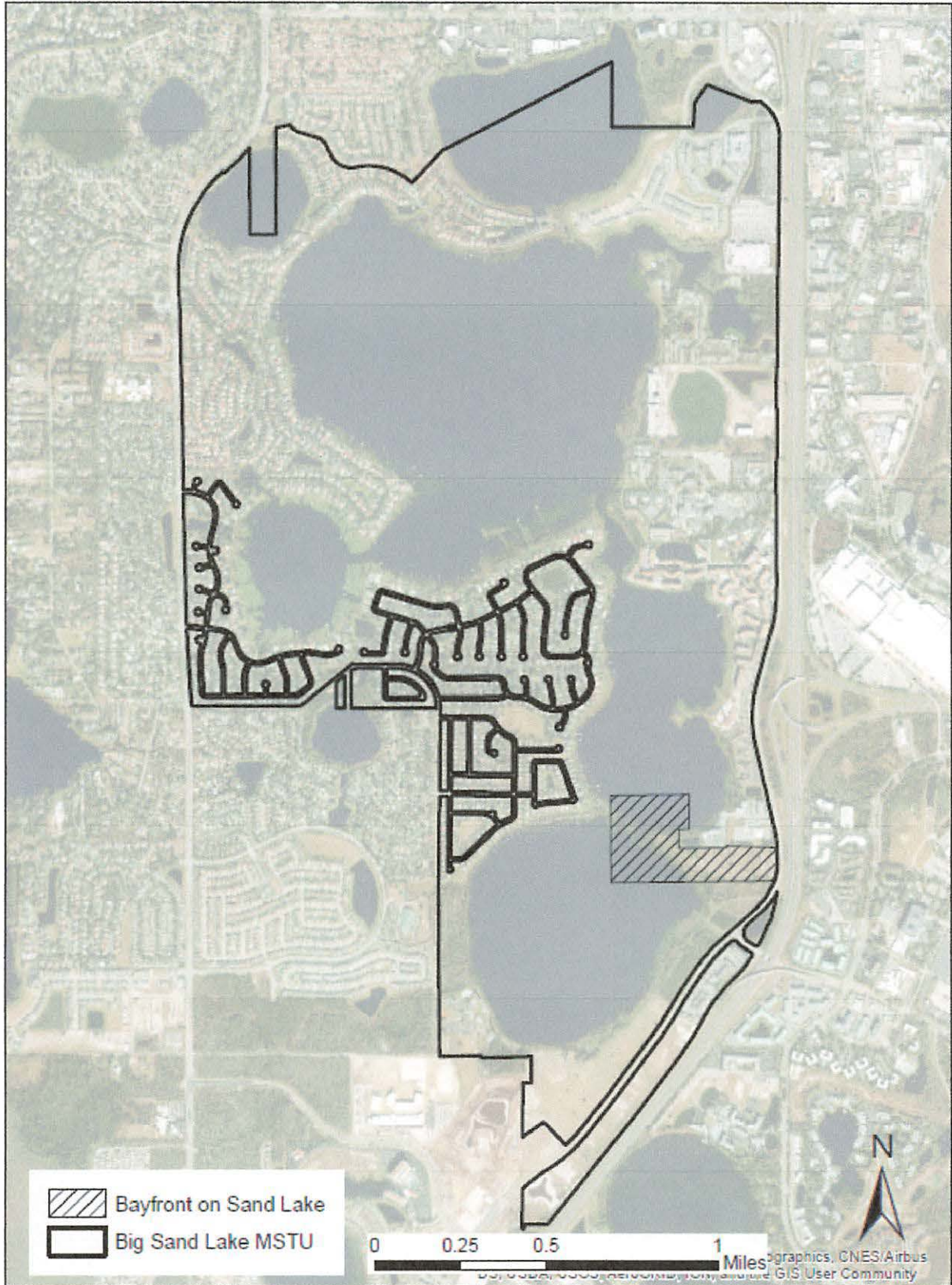
