Services

ACTION REQUESTED:

Approval to award Invitation for Bids Y21-135-AH, HVAC Installation and Repair Services, to the low responsive and responsible bidders by lot. Lot A, Climate Control Mechanical Services, Inc., in an estimated contract award amount of \$739,750 for a one-year term, Lot B, SHAW Mechanical Services, LLC, in an estimated contract award amount of \$609,625 for a one-year term, and Lot C, Climate Control Mechanical Services, Inc., in an estimated contract award amount of \$433,500 for a one-year term. Further, request authorization for the Procurement Division to renew the contracts for four additional one-year terms.

PROCUREMENT:

These contracts will provide HVAC installation and repair services throughout Orange County facilities.

APPROVALS:

The Facilities Management and Business Development Divisions concur with this recommendation.

REMARKS:

Three bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The solicitation stated the award would be made on an all-or-none total estimated bid basis, per lot to the low responsive and responsible bidder. The low responsive and responsible bidder will be awarded to Lot A, the second-low to Lot B and third-low will be awarded to Lot C. In the event competition prohibits this approach, Contractors may be awarded more than one lot.

Based on the evaluation, the bid submitted by Climate Control Mechanical Services, Inc., is considered reasonable and realistic for the services to be performed under Lot A. The offer received by SHAW Mechanical Services, LLC is considered reasonable and realistic for the services to be performed under Lot B and is less than 10% over the lowest bidder. The offer received by Climate Control Mechanical Services, Inc., is considered reasonable and realistic for the services under Lot C as it is 2% over the current contract. The offer received from Air Mechanical & Service Corp., for Lot C is more than 30% over the current contract and the low bidder, and thus not considered reasonable and realistic.

Recommendation for award is made to the low, responsive and responsible bidders, for Lot A, Climate Control Mechanical Services, Inc., for Lot B, SHAW Mechanical Services, LLC, and for Lot C, Climate Control Mechanical Services, Inc., who all meet the requirements of this solicitation.
