RESOLUTION GRANTING PETITION TO VACATE # 18-07-021

WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate that certain **portion of a 30 foot wide unopened, unimproved right-of-way known as Morrison Boulevard, containing approximately 0.62 acres** in Orange County, Florida, as described in attachment.

WHEREAS, notice of a public hearing before the Board of County Commissioners on **January 8, 2019**, was published in the **Orlando Sentinel**, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and

WHEREAS, the Board finds that the vacating of **a portion of a 30 foot wide unopened, unimproved right-of-way known as Morrison Boulevard, containing approximately 0.62 acres** will not operate to the detriment of Orange County or the public.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ORANGE COUNTY:

The county road, right-of-way, easement, or park described above is vacated as of this date and Orange County renounces any rights in it.

Begin at the Southeast corner of the Southeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 24, Township 21 South, Range 28 East, thence run South $00^{\circ}09'56''$ West, along the East line of the Southeast $\frac{1}{4}$ of said Section 24, for a distance of 923.12 feet to a point on the Northeasterly Right of Way line of U.S. Highway #441 (Orange Blossom Trail); thence departing said East line, run North $42^{\circ}42'18''$ West, along said Northeasterly right of way line, for a distance of 44.10 feet to a point of intersection of said Northeasterly right of way line with the Easterly line of HI-ALTA Subdivision per the plat thereof as recorded in Plat Book "P", Page 12 of the Public Records of Orange County, Florida; thence departing said Northeasterly right of way line, run North $00^{\circ}09'56''$ East, along said Easterly line, for a distance of 890.80 feet to a point on the South line of the Southeast $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of said Section 24; thence departing said Easterly line, run South $89^{\circ}56'53''$ East, along said South line, for a distance of 30.00 feet to the POINT OF BEGINNING.

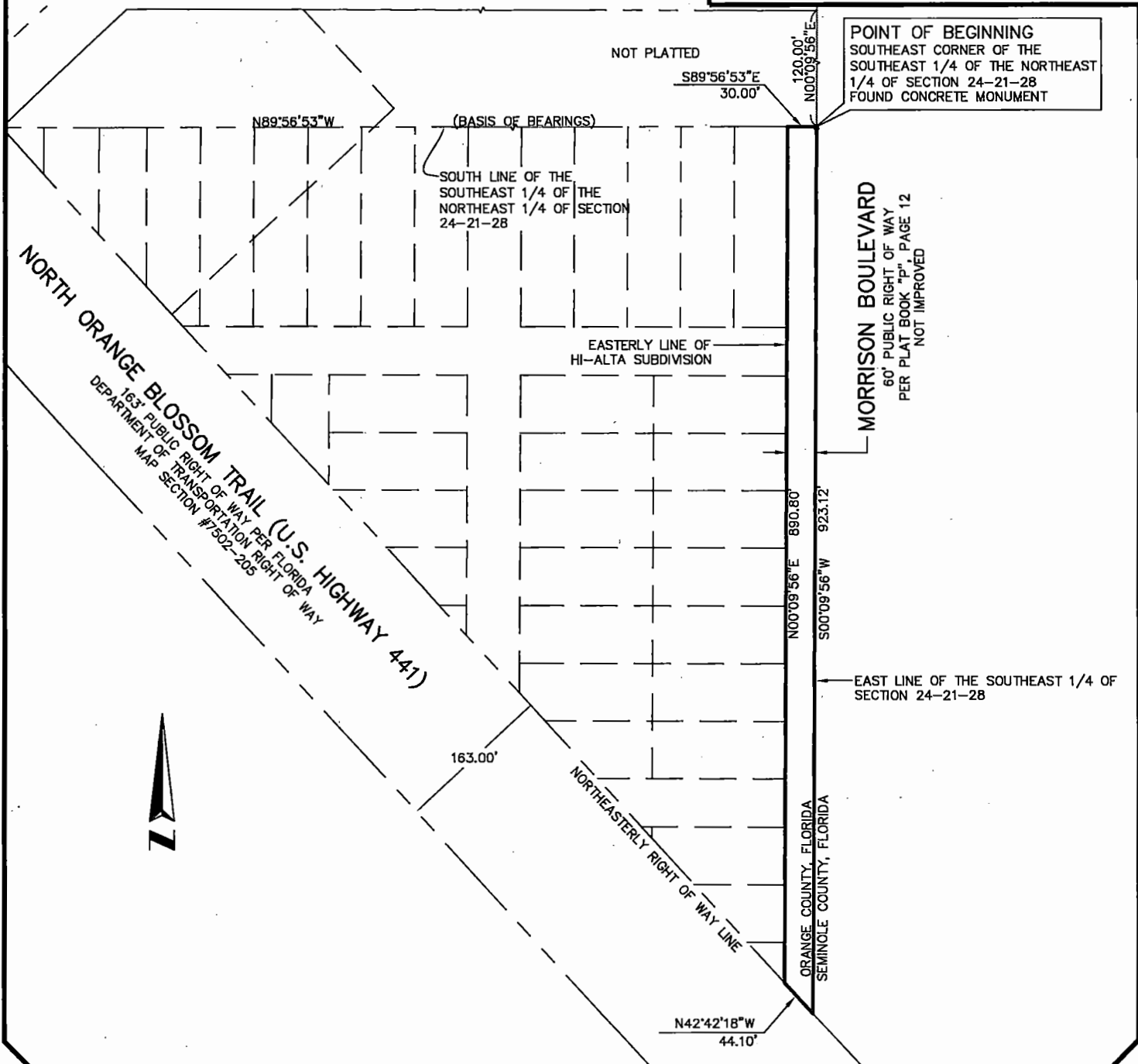
