SUBJECT: Appointments to the Code Enforcement Board DISCUSSION AGENDA ITEM JANUARY 12, 2021

The terms of three of the members of the Code Enforcement Board (CEB), Scott A. Hampton, Jany Perez, and Edward S. Johnson, expired December 31, 2020. Mr. Hampton and Ms. Perez both serve in the real estate broker/salesperson representative category and have indicated that they would like to continue serving for another term. Mr. Johnson serves in the business representative category and he did not respond to correspondence asking if he was interested in continuing to serve. In addition, Phillip C. Hollis recently resigned from the CEB. He was serving in the engineer representative category and shall need to be replaced. The terms are for three years, and the CEB does not have term limits. Appointments to the CEB are made based on nominations by the Mayor and County Commissioners.

The enabling legislation for the CEB stipulates that "the members shall be appointed on the basis of experience or interest in the fields of zoning and building control and shall, whenever possible, include: 1) an architect; 2) a businessman; 3) an engineer/surveyor; 4) a general contractor; 5) a subcontractor; and 6) a licensed real estate broker or licensed real estate salesman." In addition, the Board enacted legislation in 1993 concerning the makeup of the CEB that further provided that "subject to the preceding requirements for inclusion of certain professional specialties on the code enforcement board, each district of the county shall be represented by at least one member."
