RECOMMENDATION:

Selection of one firm and one ranked alternate to provide Professional Services for Owner Controlled Insurance Program (OCIP), Request for Proposals Y19-192-TJ, from the following firms listed alphabetically.

- Arthur J. Gallagher Risk Management Services, Inc.
- Willis of Florida, Inc.
- World Risk Management, LLC

Request authority for the Procurement Division to negotiate and execute a 5-year contract. Further request authorization for the Procurement Division to renew the contract for one additional 1-year term.

This item was evaluated by the Procurement Committee on April 10, 2019. Commissioner Mayra Uribe was assigned to the Procurement Committee.

PURPOSE:

This contract will provide professional services for the development and administration of an owner-controlled insurance program (OCIP) for the Orange County Convention Center Phase V Multipurpose and Grand Concourse Improvements Project.

DISCUSSION:

Three proposals were received in response to Request for Proposals Y19-192-TJ.

An OCIP is an insurance policy held by a property owner during the construction or renovation of a property, which is typically designed to cover virtually all liability and loss arising from the construction project.

The services solicited are necessary to provide the technical expertise and infrastructure necessary to place and administer an OCIP and to provide a variety of risk management-related services to support the OCIP program for the Orange County Convention Center Phase V Multipurpose and Grand Concourse improvements project. The contract provides risk management related services, including, but not limited to, risk analysis, underwriting, marketing/solicitation, consultation, and policy maintenance services for the duration of the contract.

The objectives of the OCIP are to:

- Reduce overall project insurance cost and expenses;
- Broaden available coverage terms and expand limits;
- Gain increased oversight over insurance, safety, communication, and community relations; and
- Maintain a healthy and safe environment for employees of the County, the contractor, and all sub-contractors.
