Approval to award Invitation for Bids Y20-124-TJ, Golf Cart Preventative Maintenance and Repair for Orange County Convention Center, to the low responsive and responsible bidder, The Forklift Medic LLC, in the estimated contract award amount of \$1,365,000 for a 3-year term. Further, request authorization for the Procurement Division to renew the contract for two additional 1-year terms.

PROCUREMENT:

This contract will provide preventive maintenance tasks, as-needed repairs, and supply all necessary equipment, service manuals, labor, and supplies required to perform the services on golf/utility carts for the Orange County Convention Center (OCCC).

FUNDING:

Funding will be available in account 4430-035-0922-3820.

APPROVALS:

The OCCC and Business Development Division concur with this recommendation.

REMARKS:

Four bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The Forklift Medic LLC has the necessary manpower and equipment to perform this contract. Sustainability initiatives are achieved by providing preventative maintenance on OCCC golf/utility carts to prolong the life of the units by at least five years and to also improve air quality of the environment by adhering to federal and state guidelines when utilizing and monitoring oil and gas products that are high quality and have low pollution emittance.
