ACTION REQUESTED:

Approval to award Invitation for Bids Y20-1024-AH, Orange County Corrections Glass Replacement, to the sole responsive and responsible bidder, Basso Enterprises LLC dba Orange County Glass, in the estimated contract award amount of \$367,695 for a three-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

This contract secures a contractor to provide and install replacement glass as required at the Corrections Department.

REMARKS:

A single bid was received in response to the Invitation for Bids (IFB) and was evaluated for responsiveness and responsibility. The references were excellent and award is recommended to the sole responsive and responsible bidder, Basso Enterprises LLC dba Orange County Glass. The bidder has held this contract with the County for multiple years and has provided consistent, timely and effective services. The bid is considered reasonable based on comparison to our current contracted prices.

To ensure an open and competitive bid process, the IFB was posted on the Orange County website and the Negometrix portal. A query from staff to potential bidders that declined to compete in this solicitation resulted in the following:

- Hanssen Glass, LLC: routed inquiry to President/COO but received no response.
- K&K Glass: did not submit a bid due to backlog of existing business.
- Lloyd's Glass Services: vendor misunderstood bid requirements, believed it was to perform work at all Orange County locations.
- Keating Glass Corporation: vendor unable to bid due their current workload.
