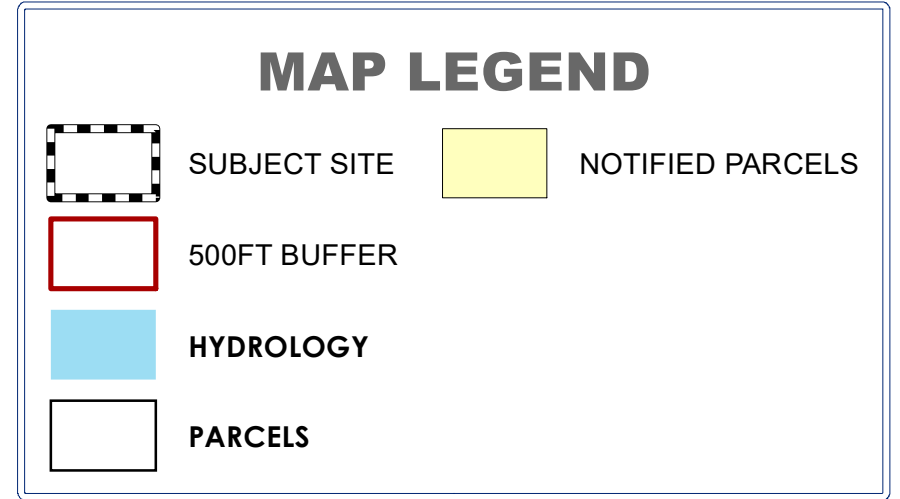

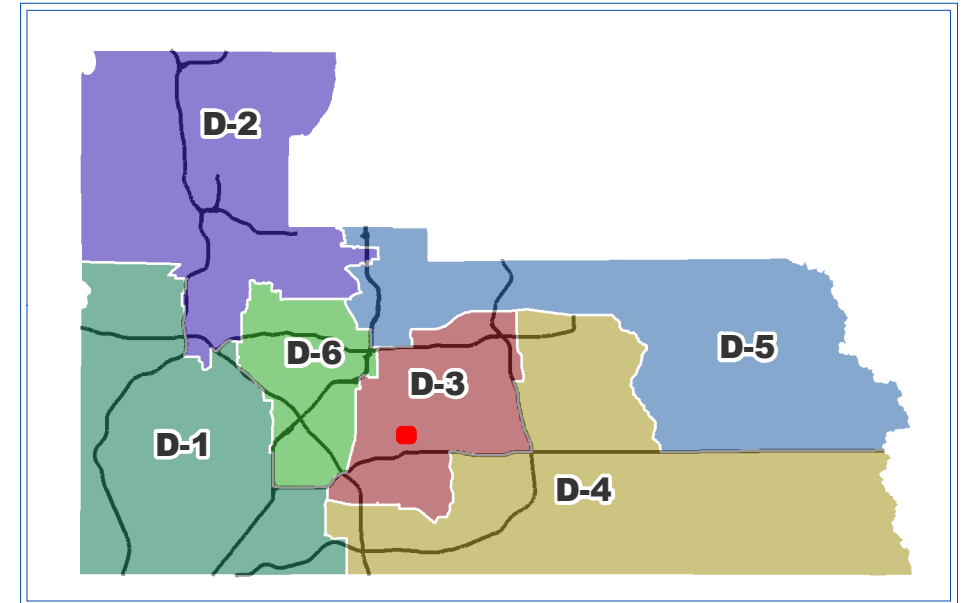

Public Notification Map

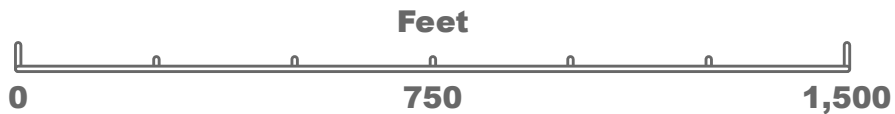
