ACTION REQUESTED:

Approval to award Invitation for Bids Y23-138-RM, Operable Partitions and Air Walls Preventative Maintenance and Repairs, to the sole responsive and responsible bidder, SSE Space Management, LLC, in the estimated contract award amount of \$979,342.50, for a one-year term. Further request authorization for the Procurement Division to renew the contract for four additional one-year terms.

PROCUREMENT:

This contract will provide maintenance services and semi-annual inspection to repair and maintain operable door partitions and air walls located on both campuses of the Orange County Convention Center (OCCC). These partitions are installed and removed by OCCC staff and must be maintained in a safe and functional manner. Additionally, these partitions are a critical asset to meeting the operational requirement for clients of the OCCC.

FUNDING:

Funding is available in account number 4430-035-0922-3810.

APPROVALS:

The OCCC and Business Development Division concur with this recommendation.

REMARKS:

One bid was received in response to the Invitation for Bids (IFB) and was evaluated for responsiveness, responsibility, and price reasonableness. Price reasonableness was established by comparing labor hourly rates and parts costs with current County contracts for similar services. Daily and weekly rates for lift rentals were compared to the rates charged by United Rentals according to their online price list. SSE Space Management, LLC has the necessary qualifications, resources, and satisfactory references that support

consideration of award. Therefore, award is recommended to SSE Space Management, LLC.

In accordance with the Procurement Ordinance, a negotiation meeting was held, resulting in reductions to numerous line item prices, decreasing the annual bid total by \$127,807.50.

To ensure an open and competitive bid process, the IFB was posted on the County's eprocurement platform. A query from staff to potential bidders that declined to compete on this solicitation resulted in the following:

- D.H. Pace Company, Inc. No response to the inquiry.
- Gymdoors Florida, LLC No response to the inquiry.
