ACTION REQUESTED:

Selection of SGM Engineering, Inc. to provide Design Services for Design Services for Orange County Convention Center West Building - Building Automation System and Heating, Ventilation and Air Conditioning (HVAC) Upgrades, Request for Proposals, Y23-808-GO.

Request authorization for the Procurement Division to negotiate and execute a contract with a not-to-exceed budget of \$4,555,491.

The proposal was evaluated by the Procurement Committee on January 11, 2023. Commissioner Michael Scott was assigned to the Procurement Committee.

PROCUREMENT:

This contract will provide final design and construction plans for the building automation system and HVAC upgrades. These systems support food service, exhibit halls, public concourse space, and other building controls. In addition to upgrading obsolete hardware and software, the Convention Center requires a design that is better adapted to its core business - hosting meetings, conventions, and tradeshows for clients who lease convention space. This project is located in District 6.
