On May 5, 2020, the Board accepted the initial Ambient Air Grant awarded to the Environmental Protection Division, from the U.S. Department of Environmental Protection Agency (US EPA), in the amount of \$35,000 and have since approved amendments No. 1 through No. 4, increasing the total award amount to \$140,994. The US EPA is now awarding amendment No. 5 in the amount of \$35,561, which will increase the total award amount to \$176,555. The budget period for this grant is from April 1, 2020 through March 31, 2025.

The purpose of this funding is to support the ongoing collection of data on the ambient air concentration of fine particulate matter and to support Orange County's efforts with staying in compliance with National Ambient Air Quality Standards.

On September 19, 2024, the Board approved an estimated budget for the U.S. Department of Agriculture (USDA) Child Care Food Program grant in the amount of \$1,525,153. The USDA, through the Florida Department of Health, has awarded this grant to Orange County in the amount of \$1,935,875; this represents an increase in the amount of \$410,722. The grant period is from October 1, 2024 through September 30, 2025.

The Child Care Food Program is a federally funded program that reimburses child care providers for serving meals to eligible children. Children enrolled in Head Start are automatically eligible to receive free meal benefits.
