  - Expansion of CCC Advisory Board
- **January 29, 2019**
  - Final Report released
  - Children's Services Press Conference
  - Mayor announced 60-day timeline
- **February 12, 2019**
  - BCC approved funding categories and funding allocations



# Implementation Plan

- **Initial Grant Funding, in the next 60 days, will cover the following Areas of Critical Community Needs:**
  - **Juvenile Prevention/Diversion**
  - **Mental and Physical Health**
  - **Early Childhood Education and Care**
  - **Child and Student Homelessness**
- **Initial funding provided to existing internal and external services providers**



# Implementation Plan - Internal

- **Suggested internal programs for funding**
  - **After school programs**
  - **Crisis assistance**
  - **Increase school readiness vouchers**
  - **Juvenile prevention programs**
  - **Self sufficiency programs**
  - **Youth mental health support**

## Performance Measures (Outcomes)

- **75% of Orange County funded participants who report depression, anger, anxiety, marital difficulties or other life stressors, will report an increase in life satisfaction, as evidenced by dropping at least one (1) point on the Child Functional Assessment Rating Scale (CFARS)**

- 80% of the students in the 6th, 7th, and 8th grades, who regularly participate in the project, shall achieve, or maintain, a grade point average of 2.0 or an increase in their cumulative grade point average, from the first semester (6th grade) or previous year (7th and 8th grade)
- The overall average school attendance of regularly attending project participants shall be greater than the overall average school attendance of project non-participants
- 80% of the students regularly participating in the project shall have no initial or repeat involvement in the juvenile justice system

## Performance Measures cont.

- **75% of NCF participants will demonstrate maintained or improved health and/or safety related conditions as indicated by one of more of the following indicators:**
  - individuals who receive medical or nursing services will demonstrate maintained or improved health as evidenced by documentation;
  - individuals who receive a failed health screening will maintain or improve wellness and quality of life as evidenced through follow-up screening documentation or as indicated by prevention protocols;
  - individuals receiving school entry physical exams and/or updated immunization records will officially enter school at the start of the following school year or within 14 days of initial visit to the nurse.
