**Advertising Language:**

To rezone from R-1A (Single-Family Dwelling District) to R-1 Restricted (Single-Family Dwelling District) to split the lot and develop two detached single-family homes on minimum 50 foot wide lots.

BCC's calendar reasonably permits. Staff requests that this public hearing be scheduled on **January 13, 2026**.

(2) Unless stated otherwise, the public hearing should be advertised to begin at 2:00 p.m., or as soon thereafter as the matter may be heard.


