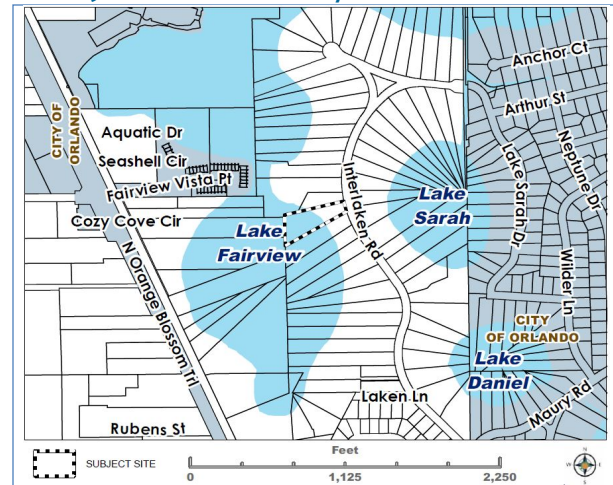

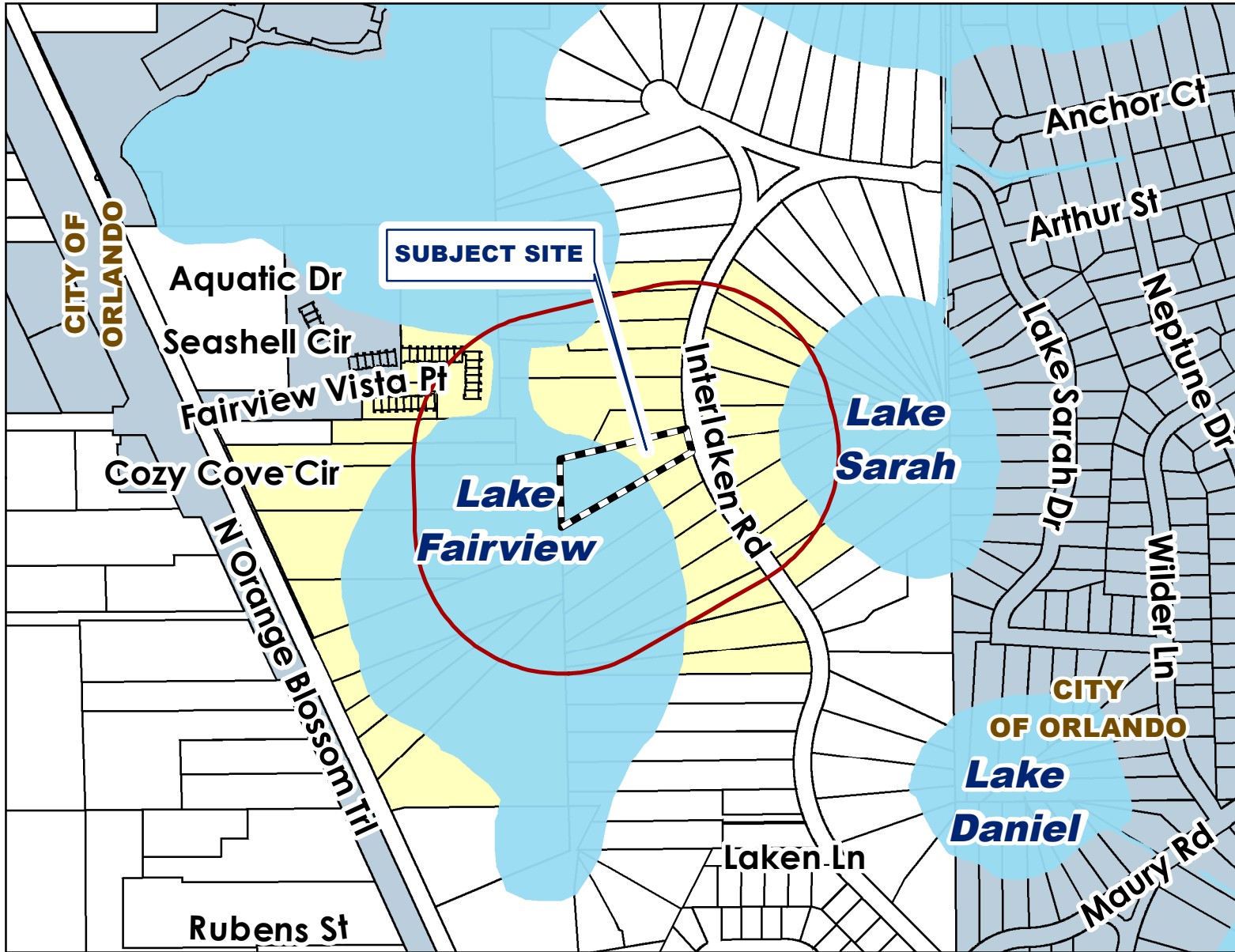

Public Notification Map

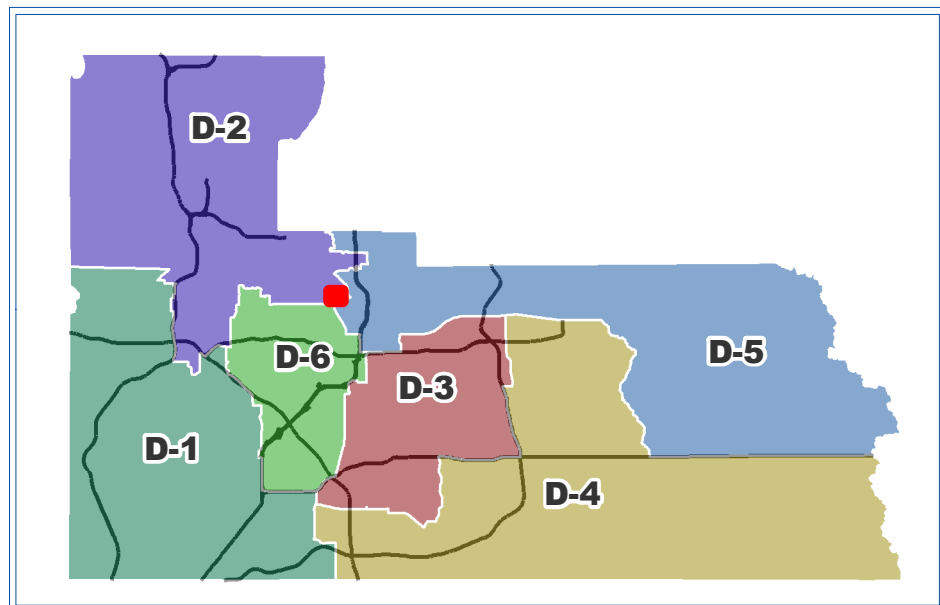

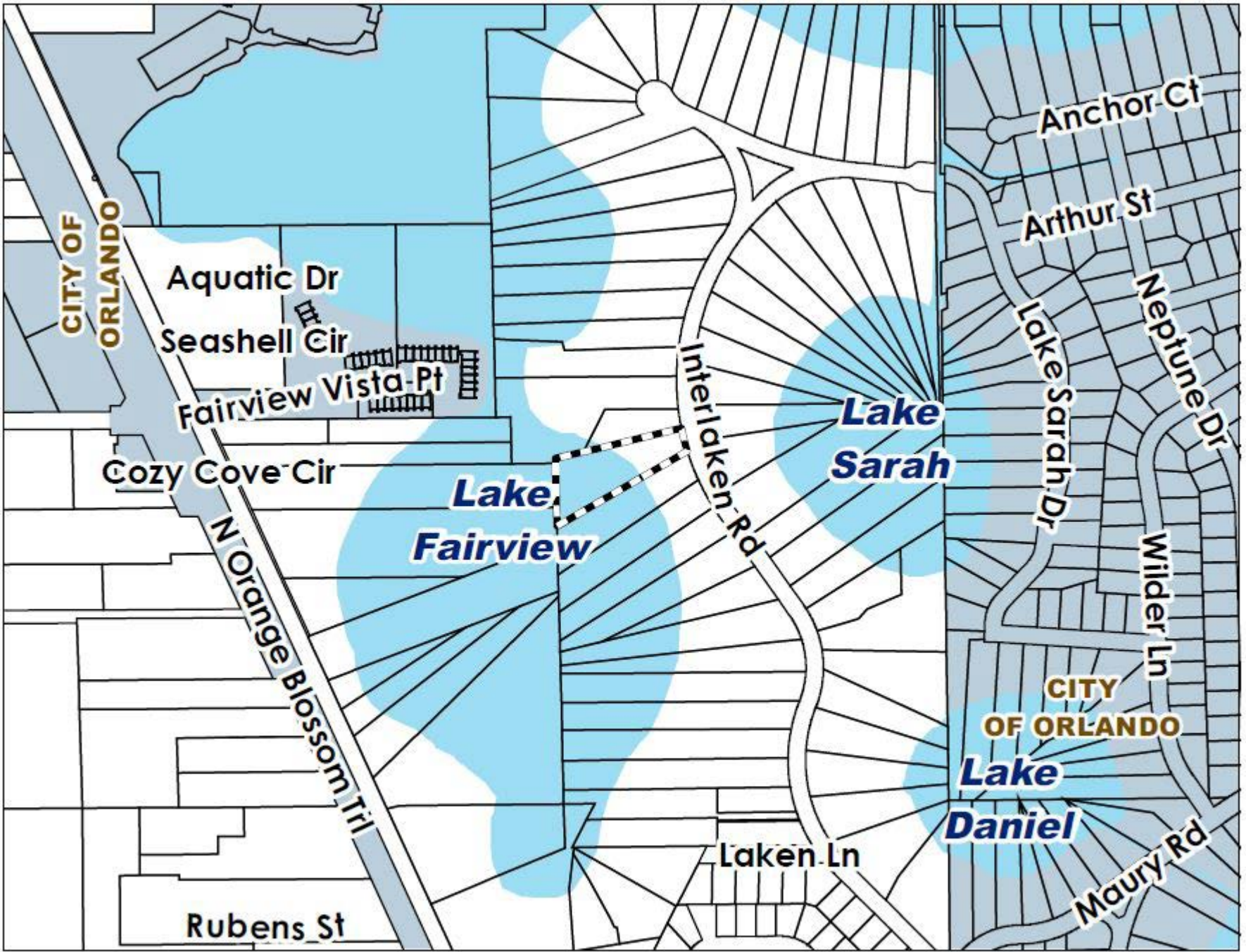

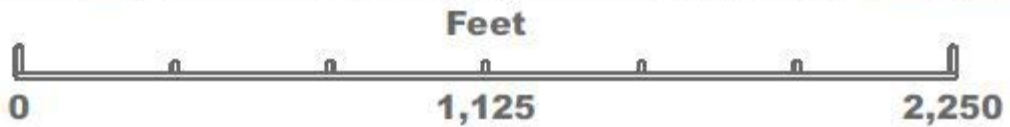
