


Timeline: Holt Borrow Pit¹


- 1. <u>02/10/2014</u> Representatives of Applicant (Roger and Joe Holt and engineer James Golden of HSA GOLDEN) met with Commissioner Jennifer Thompson and her assistant Jason Russo to meet and introduce the project to her.
- 2. <u>02/26/2014</u> Workshop at Commissioner's office attended by staff, Roger Holt and HSA GOLDEN.
- 3. <u>01/2015</u> Conservation Area Determination (CAD) application submitted to Orange County Environmental Protection Division by Bio-Tech (David Holley).
- 4. <u>07/07/15</u> Second field inspection of wetlands conducted by David Eunise, SJRWMD (first done in May).
- 5. <u>07/13/15</u>- Orange County Environmental Protection Department meeting attended by OCEPD staff including Ms. Liz Johnson, Mr. Tim Hull, Bio-Tech Consulting (Jay Baker and Larry Medlin), Joe Holt and Roger Holt.
- 6. <u>07/15/2015</u> Applicants submit Borrow Pit Permit Application.
- 7. <u>11/23/15</u> Conservation Area Determination Agreement with Orange County.
- 8. <u>04/11/2016</u> Meeting at Orange County Public Works, with staff from OC Public Works, OC Real Estate Managements, Joe and Roger Holt to discuss the proposed borrow pit application and potential rights of way donation.


