ACTION REQUESTED:

Approval of Amendment No. 5, Contract Y20-2020, Provision of Community Services and Facility Use, with Florida Economic Consortium, Inc., in the amount of \$175,000, for a revised contract total amount of \$525,000.

PROCUREMENT:

This amendment extends the contract for the period of July 1, 2023 through December 31, 2023 and provides additional funding for the extension. Aligning the contract date to the calendar year allows the contract to provide continuity of services accompanied by calendar year funding.

REMARKS:

Behavioral Therapy for Children, Youth, and Young Adults program provides evidence-informed, individualized, intensive, high-risk, high delinquency referral, and dependency involved behavioral health care services for at-risk children, youth and young adults throughout Orange County.

Reading/Math Coaches program serves West Orange County assisting students (Kindergarten through 12th grade) who are struggling with reading and/or mathematics to improve their skills
