RECOMMENDATION:

Selection of England, Thims & Miller, Inc. and Kelly, Collins & Gentry Inc. to provide Continuing Engineering Services for Right-of-Way Acquisition and Eminent Domain, Request for Proposals Y24-900-ZR.

Request the Board to authorize execution of the final contracts by the Procurement Division to establish hourly rates for future requirements for an initial one-year term with two one-year renewals.

The Procurement Committee evaluated the proposals on March 6, 2024. Commissioner Christine Moore was assigned to the Procurement Committee.

PURPOSE:

The contracts will provide continuing engineering services for right-of-way acquisition and eminent domain from design review, right-of-way impact analysis and appraisal process through settlement negotiations and the eminent domain process.

Two proposals were received in response to this Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP.
