ACTION REQUESTED:

Approval to award Invitation for Bids Y22-1079-KS, HVAC Preventative Maintenance and Repair Services, to the low responsive and responsible bidder, Mechanical Services of Central Florida, Inc., in the estimated contract award amount of \$1,480,297.57 for a one-year term. Further request authorization for the Procurement Division to renew the contract for four additional one-year terms.

PROCUREMENT:

This contract will provide HVAC and refrigeration preventative maintenance and repairs for multiple facilities throughout Orange County.

FUNDING:

Funding is available in account numbers 0001-043-1713-3810, 0001-043-1715-3810, 0001-043-1717-3810, 0001-043-1718-3810, and 0001-043-1719-3810.

APPROVALS:

The Facilities Management and Business Development Divisions concur with this recommendation.

REMARKS:

Five bids were received in response to this Invitation for Bids and evaluated for responsiveness, responsibility, and price. References were verified and provided positive performance feedback. Mechanical Services of Central Florida, Inc. has the necessary manpower and equipment to perform this contract. Price reasonableness was determined based on comparison to our previous contracted pricing. Anchor Mechanical, Inc. and ClarityChem, Inc. were deemed non-responsive for not submitting all required documents.
