SUBJECT: Business Development Division Bid Evaluation

PROJECT: Y25-713-CR, Orange County Landfill New Fuel Station

The Business Development Division evaluated the three bids submitted for this project. The Business Development Division (BDD) completed an M/WBE Availability Analysis. The scope of services for this project had limited M/WBE availability. As a result, the M/WBE goal was reduced to 22%. At the time of bid opening, at least 70 firms were certified to provide the scope of services at the subcontract level.

The apparent low bid, submitted by Prime Construction Group, Inc., reported 22.09% in M/WBE participation. Therefore, the bidder met the 22% Orange County M/WBE participation goal, **per the Ordinance requirement.**

The second low bid, submitted by Mulligan Constructors Inc., reported 26.82% in M/WBE participation. However, the bidder listed scopes of services for an Orange County Certified M/WBE firm and the firm was not certified to perform each of the scopes of services as listed.

Therefore, on January 14, 2025, BDD issued the bidder a Request for Clarification requesting that the bidder:

- 1. Please update the Contract and Sub-Contract Goal Participation Schedule Form to separately list the scope of services to be performed by Valencia Construction Group, Inc., along with each scope's dollar amount, Goal Total and Percent as highlighted below:
 - Sitework ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form
 - Demo ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form
 - Utilities ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form

• Paving – ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form

On January 15, 2025, the bidder submitted the following:

• An updated Contract and Subcontract Goal Participation Schedule Form listing each scope of service separately.

BDD excluded the sitework, demo and paving scope of services - as the listed M/WBE subcontractor is not Orange County M/WBE Certified to perform those specific scope of services. The bidder did not meet the M/WBE participation goal.

If the M/WBE participation goal is not achieved bidders are required to demonstrate that they have submitted Good Faith Effort, **per the M/WBE Ordinance requirement.** The bidder did not submit any Good Faith Effort documentation.

* Valencia Construction Group, Inc. are Orange County M/WBE certified to perform underground utility & excavation, asphalt, earthwork services, concrete flatwork to include concrete curb and the construction of retaining walls – not sitework, demo or paving.

The third low bid was submitted by Orange County Certified Minority Business Enterprise, Don Wood, Inc., who is bidding as a prime. Therefore, Don Wood, Inc. is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 22% M/WBE goal. Don Wood, Inc. reported self-performing 100%. Therefore, the bidder met the 22% Orange County M/WBE participation goal **per the Ordinance requirement.**

The fourth low bid, submitted by S.A. Casey Construction, Inc., reported 24.87% in M/WBE participation. However, the bidder listed scopes of services for an Orange County Certified M/WBE firm and the firm was not certified to perform each of the scopes of services as listed. Therefore, the bidder did not meet the M/WBE participation goal, **per the Ordinance requirement.**

Therefore, on January 15, 2025, BDD issued the bidder a Request for Clarification requesting that the bidder:

- 1. Please update the Contract and Sub-Contract Goal Participation Schedule Form to separately list the scope of services to be performed by Hussain Industries, LLC., along with each scope's dollar amount, Goal Total and Percent as highlighted below:
 - Utilities– ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form
 - Excavation ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form
 - Land clearing ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form
 - Site demo ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form
 - Concrete ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form
 - Site work ensure the scope's Dollar Amount, Goal Total and Percent is listed on the Form

On January 16, 2025, the bidder submitted the following:

• An updated Contract and Subcontract Goal Participation Schedule Form listing each scope of service separately.

BDD excluded the concrete and sitework scope of services - as the listed M/WBE subcontractor is not Orange County M/WBE Certified to perform those specific scope of services. The bidder did not meet the M/WBE participation goal.

If the M/WBE participation goal is not achieved bidders are required to demonstrate that they have submitted Good Faith Effort, **per the M/WBE Ordinance requirement.** The bidder did not submit any Good Faith Effort documentation.

** Hussain Industries, LLC. are Orange County M/WBE certified to perform utilities, excavation, land clearing, and site demo – not concrete and site work.

The fifth low bid, submitted by Carr & Collier, Inc. reported 22.13% in M/WBE participation. Therefore, the bidder met the M/WBE participation goal, **per the Ordinance requirement.**
