The purpose of this memo is to request approval of the managerial appointment of Anthony Camarillo as the General Manager for the Orange County Convention Center (OCCC). The OCCC is a complex facility comprised of approximately 7 million square feet of conditioned building space encompassing a 400-acre campus.

The OCCC General Manager will assist the Executive Director in the overall management of the building with an emphasis placed on safe and efficient operations. This position will respond to outside business and tourism organizations' needs and be responsible for the overall direction, coordination/budgeting, and evaluation of assigned divisions.

Mr. Camarillo has over 30 years of industry experience, beginning his career at the Metropolitan Pier and Exposition Authority, McCormick Place, in 1990 as an Event Manager. In 1994 he joined the Metropolitan Pier and Exposition Authority – Navy Pier. He assisted in opening the new facility, hiring and developing new staff, and developing building guidelines, procedures, and standards of operation. Throughout his career at the Navy Pier, Mr. Camarillo has held many positions, including Director of Entertainment Operations, Director of Special Events, Director of Event Management, Senior Director of Sales and Events, and finally, Director of Sales and Events.

Currently, Mr. Camarillo is the Executive Director of the RP Funding Center/City of Lakeland – a position he has held since 2015. In this position, Mr. Camarillo oversees the overall management of the venue, including sales, marketing, operations, event management, and catering. He was tasked with overseeing an \$18 million renovation upgrade to all meeting rooms, common space, restrooms, new seating, stage in the theater, and upgrades to the arena.

Mr. Camarillo's appointment will be effective the first full pay period following Board approval at an annual salary of \$175,032.
