RECOMMENDATION:

Selection of three firms and an alternate to provide Cost Estimating, Scheduling, and Project Management Services for the Orange County Convention Center, Request for Proposals Y23-137-TF, from the following firms listed alphabetically:

- Cost Management, Inc. dba CMI
- Kraus-Manning, Inc. dba KMI International
- PMA Consultants, LLC
- Procon Consulting, LLC

Further request Board authorization for the Procurement Division to negotiate and execute three contracts in within an overall budget of \$3,746.538 for a three-year term. Further request authorization for the Procurement Division to renew the contracts for two additional one-year terms.

The proposals were evaluated by the Procurement Committee on March 1, 2023. Commissioner Christine Moore was assigned to the Procurement Committee.

DISCUSSION:

The contractors will provide cost estimating, scheduling, and project management service to assist the Orange County Convention Center staff with current and future specific task authorizations of the Capital Improvement Program. These services, on an as-needed basis, will consist of cost estimating, scheduling, schedule evaluations, project management, owner's representative services, general project administration, construction management administration, claims management, reporting, project closeout, and legal support or testimony services. The Orange County Convention staff anticipates that three firms will be required to meet the projected demand for these services.

Five proposals were received in response to this Request for Proposals (RFP) and were evaluated in accordance with the criteria set forth in the RFP. The proposal received from Colliers Project Leaders USA NE, LLC scored too low for Board consideration. The consensus scores of the Procurement Committee are attached.
