ACTION REQUESTED:

Approval to award Invitation for Bids Y18-1083-AV, Right-of-Way Mowing – West Orange Area, Section III, to the low responsive and responsible bidder, Lawnwalker Services, Inc., for an estimated contract award amount of \$425,555 for a 1-year term. Further request authorization for the Procurement Division to renew the contract for three additional 1-year terms.

PROCUREMENT:

To provide right-of-way mowing for County owned properties.

FUNDING:

Funding is available in account 1002-072-2906-3816.

APPROVALS:

The Roads and Drainage Division and Business Development Division concur with this recommendation.

REMARKS:

Three bids were received from pre-qualified bidders in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Lawnwalker Services, Inc. has a satisfactory record of performance and is considered responsible. Prices have been determined reasonable as compared to current contracted pricing. Therefore, award is recommended to Lawnwalker Services, Inc.



Hence, the bid preference program in accordance with the County's M/WBE Ordinance, Section 17-324 cannot be applied.
