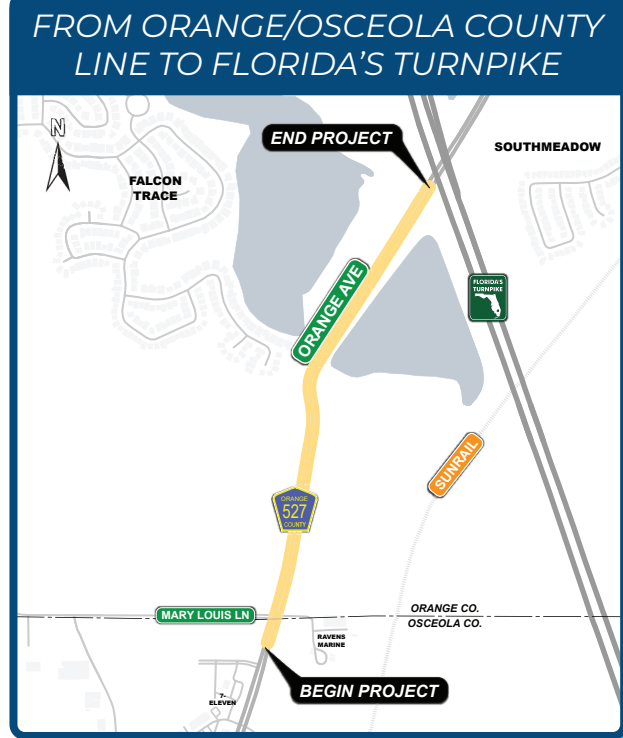

Project Summary

Orange Avenue is planned to be widened from two lanes to four lanes between the Orange/Osceola County Line and the Florida's Turnpike, a distance of approximately 0.6 miles. The project includes in-pavement bicycle lanes in each direction along with sidewalks along both sides of the roadway. Additional improvements will include upgraded drainage systems, enhanced roadway lighting, intersection upgrades, and landscaping.

This roadway widening will increase capacity to accommodate future travel demands, reducing congestion and improving overall traffic flow. The addition of bicycle lanes and sidewalks will enhance safety and connectivity for pedestrians and bicyclists, creating a more accessible and multimodal corridor.
