PROCUREMENT:

This contract will provide new kitchen equipment for essential services to serve clients and visitors through the upgraded cafes and kitchens.

REMARKS:

Six bids were received in response to this Invitation for Bids (IFB) and evaluated for responsiveness, responsibility and price reasonableness. Central Restaurants Products, Clark Associates Inc., dba Clark Food Service Equipment, Douglas Equipment, and Sam Tell & Sons, Inc. was deemed non-responsive for failure to submit mandatory bid forms. Chef's Depot was deemed non-responsible for failure to meet the reference requirements of the IFB. HMAK, LLC has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to HMAK, LLC.
