SUBJ: Avalon Park Bike Path – Amendment to Donation Agreement

On September 14, 2021, the Board approved the Donation Agreement between Avalon Park Property Owners Association, Inc. (Avalon) and Orange County (County) for the donation of right-of-way for the purpose of the County taking over the maintenance and operation of bike paths that traverse the common areas in Avalon Park (Avalon Park Bike Path).

Unfortunately, after the Donation Agreement was approved, it was determined that Avalon's surveyor included certain areas in the legal description that were already owned by the County. Therefore, a new legal description was requested to fix the errors, and an Amendment to the original Donation Agreement is now needed to move forward with the donation of the right-of-way.

In accordance with Florida Statutes, a Warranty Deed will be prepared which transfers all interest, authority, and responsibility over those portions of the Avalon Park Bike Path to the County. Upon the approval of the Amendment to Donation Agreement and performance of the "Due Diligence Contingency" of the Agreement, Real Estate Management will perform the closing of the transaction on those portions of the Avalon Park Bike Path that will transfer to the County.

The County Attorney's Office and Real Estate Management Division have reviewed the Amendment to Donation Agreement and found it acceptable to form.

Action Requested: Approval and execution of Amendment to Donation

Agreement between Avalon Park Property Owners Association, Inc. and Orange County; approval of the Warranty Deed from Avalon Park Property Owners Association, Inc. to Orange County; and authorization to perform all actions necessary and incidental to closing.

AMENDMENT TO DONATION AGREEMENT

COUNTY OF ORANGE STATE OF FLORIDA

THIS AMENDMENT TO DONATION AGREEMENT is made between **Avalon Park Property Owners Association, Inc.**, a Florida non-profit corporation, hereinafter referred to as OWNER, and **Orange County**, a charter county and political subdivision of the state of Florida, hereinafter referred to as COUNTY.

WITNESSETH:

WHEREAS, OWNER and COUNTY entered into a Donation Agreement ("the Agreement") with an effective date of September 14, 2021, under which the OWNER agreed to donate land to the COUNTY for the Avalon Park Bike Path; and

WHEREAS, the land described on **Exhibit "A"** to the Agreement mistakenly included land owned by the COUNTY; and

WHEREAS, accordingly, the parties hereto desire to enter into this Amendment to the Donation Agreement (the "Amended Agreement") that substitutes a corrected **Exhibit "A"** for the incorrect **Exhibit "A"** attached to the Agreement; and

WHEREAS, furthermore, the parties desire to extend the date the transaction shall be closed and the Warranty Deed and other papers delivered; and

WHEREAS, the parties desire that, in all other respects, the terms and conditions of the Agreement shall remain unchanged by this Amendment and in full force and effect.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00), each to the other paid, the parties hereto agree as follows:

- 1. The attached Exhibit "A" is hereby substituted for, and therefore supercedes and replaces, Exhibit "A" attached to the Agreement.
- 2. The transaction described in the Agreement shall be closed and the Warranty Deed and other papers delivered on or before ninety (90) days from the effective date of this Amendment.
- 3. The Manager of the Orange County Real Estate Management Division is hereby authorized, on behalf of the COUNTY, to perform all actions necessary and incidental to closing on this Amended agreement, including an extension of the closing date, if needed, up to sixty (60) days.
- 4. In all other respects, the Agreement shall remain unchanged and stay in full force and effect.

5. This Amended Agreement shall become effective on the date upon which it is approved by the Orange County Board of County Commissioners.
